## The pilot process

Sheryl and her team arranged a pilot group of 10 members of staff across various departments to trial compareDocs. "The compareDocs pilot process was successful," said Sheryl. "The application deployed easily, and there were no issues. It integrates well with iManage, which was a big factor in our decision." Importantly, staff found compareDocs to be a fast and accurate comparison tool that "works as it is supposed to."

## Deployment and training

After the pilot process, Sheryl began the work of rolling compareDocs out to the rest of the firm. To help get users up to speed, a DocsCorp sales engineer put together a compareDocs training video, and Taft's product trainer made a side-by-side comparison video of what the old application did and what compareDocs does.
